	<p>cease operation of the bollards there has been an increase in parking in the city centre. Gwent Police have issued 550 parking tickets in the past 2 and a half months and this is not sustainable. GF felt that there now needed to be an assessment of safety as a result of illegal parking. SD updated the group about the Car Parking Strategy. A recent study suggests that Newport has enough car parking spaces and that the cost of these is cheap when compared to other cities. The strategy was co-ordinate travel and parking and may include pedestrianizing part of the city centre.</p> <p><u>Health and Wellbeing</u> BJ raised the issue about information systems and working across services. We need to identify if there are any on-going issues. SA raised Active Travel. We need to agree an approach at SIP Board and then take this out to partners. Up to date information systems will be needed across the partnership.
